Terms of the proficiency test (PT)

DLA 34/2019 - GVO-Screening II (qualitative): 5 Samples with positive/negative amounts of GMO-Potato Amflora (EH92-527-1), GMO-Rape Seed / Canola (GT73, MON88302) and GMO-Sugar Beet (H7-1)

Test material* :

There are 5 different samples with positive / negative amounts of GMO-Potato Amflora (EH92-527-1), GMO-Rape Seed / Canola (GT73, MON88302) and GMO-Sugar Beet (H7-1) with the screening parameters t-NOS, p-FMV, p-NOS / nptII and CP4 EPSPS in different Matrices (flour and powder mixtures).

Sample weight: 5 samples 10 g each.

* <u>Note:</u> Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The **evaluation** is carried out **strictly qualitatively** (positive/negative) with indication of the obtained agreements with the consensus values of the participants and the spiking of samples 1-5.

All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done.

Registration :

The reliable order can be sent to DLA or our authorized sales partner.

Shipment + number of participants:
