# DLA ptALR1 (2021) Response PT Peanut: Processed samples Peanut (unroasted), Peanut (roasted), Peanut Butter, Peanut Paste and Extrudate (Peanut-Flips) in potato powder matrix (levels: 25 - 150 mg/kg)

### Test material\*:

There are **5 differently processed samples** of the food allergen **Peanut** (unroasted), **Peanut** (roasted), **Peanut Butter** (spread), **Peanut Paste** (spice paste) **and Extrudate** (peanut-flips) as well as the "blank"-sample (matrix) for determination. The allergens are contained in a simple carrier matrix (potato powder / maltodextrin) in the range of 25 - 150 mg/kg. The individually processed allergenic ingredients were mixed from at least 4 different common in commerce products.

Sample weight: 6 samples 20 g each.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

### **Methods + realisation time:**

Analytical methods for qualitative and quantitative determinations are optional.

There is a 8 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

# **Evaluation report:**

The **evaluation** is carried out **qualitatively** (inscores of 1-5) and quantitatively by **recovery rates** indicating the **response** of the processed allergens. The target values are the respective spiked amounts. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission. Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
