Terms of the proficiency test (PT)

DLA ptRE02 (2021) - Detection of Food Irradiation: Spices, ground and Herbs, rubbed

2 different samples each (irradiated / non-irradiated)

Test material*:

There are **two different samples** each of a **mixture of Spices** (ground) and a **mixture of herbs** (rubbed). One of the two samples was treated with ionizing radiation (range 0.5-10 kGy).

Sample weight: 2 Samples of spice mixture 40 g each, 2 samples of herb mixture each.

* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Suitable analytical detection methods are photonstimulated luminescence (PSL) and thermoluminescence (TL).

There is a 8 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The **evaluation** is carried out **strictly qualitatively** (positive/negative) with indication of the obtained agreements with the consensus values of the participants and the irradiation of samples A+B and C+D, respectively. All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
