Terms of the proficiency test (PT)

DLA ptASW1 (2022) - Allergen Swab Test I: Gluten, Peanut, Milk and Soya (2 Test Surfaces per Allergen, qualitative)

Test material*:

There are **8 test areas** possibly containing the allergenic parameters **Gluten**, **Peanut**, **Milk** and **Soya** for qualitative determination. 2 areas are to be tested per allergen (one of each is positive). The amounts are in the range of 10 - 100 μ g/test surface.

Sample number: 8 test surfaces of approx. 30 cm².

* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

The analytical methods are optional. There is a 8 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

Evaluation report:

The **evaluation** is carried out **strictly qualitatively** (positive/negative) with indication of the obtained agreements with the consensus values of the participants and the spiking of the test areas.

All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report **in English** as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

Registration:

Shipment + number of participants:

Required minimum number of participants is 10. The samples will be sent to participants in the **week 12** by package service with tracking (delivery time 2-5 days within Europe, 2-10 days worldwide).

Deadline of result submission:

Last date for submission of results 20th May 2022.

Invoice + price:

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price for the proficiency test is 360,-- € per participant plus shipping and tax.
