# DLA ptMYS1 (2022) - Mycotoxin-Screening: Aflatoxins, Ochratoxin A, Deoxynivalenol, Zearalenone and Fumonisins in Breaktfast Cereals

(Muesli with corn and other cereal products, almonds and dried fruits, qualitative and quantitative)

#### Test material\*:

There are **two different samples A and B** with the parameters **Aflatoxins, Ochratoxin A, Deoxynivalenol, Zearalenon and Fumonisins** to be determined. The **matrix** is **breakfast cereals** (ground, with corn and/ or other grain products). One of these samples contains ingredients with a natural content of the respective mycotoxins.

**Up to 3 parameters** or up to **5 parameters** can be registered for and optionally analyzed.

Sample weight: 2 Samples 200 g each.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

#### <u>Methods + realisation time:</u>

Analytical methods for quantitative determinations are optional.

There is a 8 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

## **Evaluation report:**

The **evaluation** is carried out **qualitatively** (positive/negative) and from a total of 7 results on **quantitatively**. It includes kernel density estimation, outlier tests, robust mean, robust standard deviation and z-scores. The assigned value is the robust mean of participants results. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
