# DLA ptAL10 (2023) Allergens X: Gluten and Soya in Oat Drink and Rice Drink (4 different Samples)

## Test material\*:

There are four different samples A, B, C and D possibly containing the allergenic parameters Gluten and Soya in the range of mg/kg in the matrix Oat Drink (samples A and B) and the matrix Rice Drink (samples C and D). In each case one of these matrix samples was prepared adding the allergenic ingredients.

Sample weight: 4 samples 25 g each.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

## Methods + realisation time:

Analytical methods for qualitative and quantitative determinations are optional.

There is a 7 weeks period for performing the analysis. The results are transmitted online via our customer portal.

#### **Evaluation report:**

The evaluation is carried out qualitatively (positive/negative) and from a total of 5 results on quantitatively. It includes kernel density estimation, outlier tests, robust mean, robust standard deviation and z-scores. The assigned value is the robust mean of participants results. For information a recovery rate of the "positive" samples are calculated including zscores. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission. Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
