Terms of the proficiency test (PT)

DLA ptALM1 (2023) - ALM-Verification Crustaceae: 5 Samples containing King Prawns in Vegan Spread

(levels: 10 / 100 / 250 / 375 / 500 mg/kg)

Test material*:

For the Action Level Matrix Verification Test (ALM) a set of **5 samples with specified contents of King Prawns** as well as a "blank sample" are provided for determination in the **matrix** of **vegan Spread** (boiled). The allergenic ingredient was heated in the matrix. The level of the middle sample (appr. 250 mg/kg as Crustaceae total protein) corresponds to the Action Level 1 (VITAL concept 3.0) and judgement value of the German Commission ALTS/ALS, respectively. The 6 PT samples are blind-encoded, so that the allergen contents are not recognizable by the sample labeling.

Sample weight: 6 samples 20 g each.

* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

Methods + realisation time:

Analytical methods for qualitative and quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted online via our customer portal.

Evaluation report:

The evaluation of PT-results is carried out qualitatively (positive/negative) in scores of 1-5 (for example score 3 = Action Level successfully identified). Quantitative results will be reported for information by its recovery rates. From 5 quantitative results one level will be evaluated by z-scores for information. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission. Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
