# DLA ptAU05 (2023) Steviosides in Drink Powder

#### Test material\*:

There are **two identical samples** with the parameter **steviolalycosides** to be determined. The **matrix** is drink powder with plant protein (for preparation of a flavoured cold drink).

Sample weight: 2 Samples 25 g each.
