Terms of the proficiency test (PT)

# DLA ptALM2 (2021) - ALM-Verification Gluten: 5 Samples containing Wheat Flour in "gluten-free" Pastry (levels: 2,0 / 10 / 20 / 50 / 100 mg/kg)

#### Test material\*:

For the Action Level Matrix Verification Test (ALM) a set of **5 samples with specified contents of Gluten** as well as a "blank sample" are provided for determination in the **matrix** of **biscuit with cocoa**. The allergenic ingredient (mixture of wheat flours) was baked in the matrix. The gluten level of the middle sample (appr. 20 mg/kg) corresponds to the Action Level 1 (VITAL concept 2.0/3.0), judgement value of the German Commission ALTS/ALS and regulation EU 828/2014, respectively. The 6 PT samples are blind-encoded, so that the gluten contents are not recognizable by the sample labeling. **Sample weight:** 6 samples 20 g each.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

## **Methods + realisation time:**

Analytical methods for qualitative and quantitative determinations are optional.

There is a 8 weeks period for performing the analysis. The results are transmitted by e-mail via the provided results file.

## **Evaluation report:**

The **evaluation** of PT-results is carried out **qualitatively** (positive/negative) in scores of 1-5 (for example score 3 = Action Level successfully identified). **Quantitative results** will be reported for information. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission. Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

### **Registration:**

### **Shipment + number of participants:**

Last date for submission of results 02<sup>nd</sup> July 2021.

### Invoice + price :
