### Test material\*:

There are 4 different samples possibly containing Beef, Poultry (Duck and Chicken), Sheep and Goat for qualitative determination. The parameters are contained in the matrix of Meat Product (Sausage Meat) with amounts of 1 - 90%. Sample weight: 4 samples 30 g each.

\* Note: Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

## <u>Methods + realisation time:</u>

All results including quantitative results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.
