Terms of the proficiency test (PT)

# DLA ptSU03 (2025) Food Supplement III: B, Ca, Cr, Cu, Fe, K, Mg, Mn, Mo, P, Se, Zn and TiO2 in Capsule Powder

(enriched / high levels) (**NEW:** with Titanium Dioxide)

## Test material\* :

There are **two identical samples** with the parameters: **B**, **Ca**, **Cr**, **Cu**, **Fe**, **K**, **Mg**, **Mn**, **Mo**, **P**, **Se**, **Zn** and **TiO2** to be determined. The **matrix** is **tablet and capsule powder** (without capsule shell). The contents are of the order of the nutrient reference values per recommended daily dose (1-3 tablets/capsules approx. 0.5 - 1.5 g).

## Sample weight: 2 Samples 10 g each.

\* <u>Note:</u> Control of mixture homogeneity and qualitative testings are carried out by DLA. Any testing of the content, homogeneity and stability of PT parameters is subcontracted by DLA.

### Methods + realisation time:

Analytical methods for quantitative determinations are optional.

There is a 6 weeks period for performing the analysis. The results are transmitted online via our customer portal.

## Evaluation report:

The **evaluation** is carried out from a total of 7 results on **quantitatively**. It includes kernel density estimation, outlier tests, robust mean, robust standard deviation and z-scores. The assigned value is the robust mean of participants results. Results, limits of detection and/or quantification and remarks to the methods will be documented. DLA intends to finish the evaluation report within 6 weeks after deadline of results submission.

Each participant receives an anonymized, complete evaluation report as a PDF-file, identifying the own results by individual code in case payment was done and can object in writing to the evaluation within 6 weeks.

## **Registration :**

## Deadline of result submission:

Last date for submission of results 2025-08-15.

### Invoice + price :

Invoicing will be done by DLA along with the sample shipment or by our authorized partner in parallel to the sample shipment.

The price of the proficiency test is  $380,- \in$  per participant plus shipping and possible tax.
